ANNUAL PARISH MEETING 2020

This meeting was due to be held on 14th May 2020, but at that time there was a Covid-19 Coronavirus pandemic. The UK Government passed a new piece of legislation known as Coronavirus Act 2020. The Minutes of the 2019 Annual Parish Meeting were considered and approved at the Annual Parish Council Meeting on 12th May 2020 which was held by way of video conferencing.

The Parish Clerk has contacted all clubs and organisations that would usually submit an annual report at the Annual Parish Meeting and this is a record of the reports that have been filed.

Reports from local organisations and clubs

St Clare Churchwarden Report (2019)

During 2019 St Clare Church has benefitted from a full internal redecoration. The cracks mentioned in the last church Quinquennial Report, have been repaired although there is some concern they may reappear due to the nature of the subsoil and extreme weather conditions. The owner of the redecorating firm gifted the church a new internal oak door. This was placed between the nave and tower. Once again we have to thank a local family for regularly cutting the churchyard grass and we are grateful to another parishioner for donating and planting a large number of hedging species around the church boundary.

We have seen a fall in the Electoral Roll for a variety of reasons and sadly the PCC has also reduced in size. The latter has meant we can no longer be represented at Deanery Synod, and we now need to appoint a new Electoral Roll Officer. Our Treasurer and Churchwarden/Secretary remain the same. St Clare continues to hold two services each month on a regular basis. Congregations for the morning Holy Communion are well attended also Evening Prayer has good congregation numbers. On both occasions we are very grateful to church members from within the Benefice for their kind support. The Harvest Festival, followed by a Village Harvest Supper in the Village Hall, was a great success. We were also very pleased with the number of people who shared Easter and Christmas Celebrations. It was a delight to share our good fortune with contributions to the Food Bank and support for charities such as FCN and the Bury Drop in Centre at Looms Lane, Bury St Edmunds.

St Clare Church is beautifully cared for and has a loyal group of supporters who take part in a weekend opening rota during the Summer months. This Winter villagers have enjoyed the new external lights in the churchyard. For this we have to thank a benefactor, again from our village.

During the year we have continued to fund raise by holding various events in the village. We began in the Spring with a lovely Open Garden event at The Lodge, this was followed by the Harvest Supper in September and an Autumn Quiz in October. In November over 50 people heard about the preparations for and the events occurring when sailing around Britain.

Our PCC is very grateful for the enthusiastic and caring support we receive from St Clare residents. It enables us to ensure the church is a warm and welcoming centre of peace, available for all to visit and enjoy.

KIT Cafe

The Kit Café has gone from strength to strength since its opening in August 2018. Several villagers offer help in the kitchen and bake cakes or biscuits. There is always a quiz compiled by Margaret Fayers on the month's theme and a small prize for most correct answers. This year's most memorable openings were:

September – MacMillan Coffee Morning with over 60 visitors raised a record breaking £650

December – Christmas opening with the hall decorated with Christmas Tree and trimmings. Christmas music and lots of Christmas treats attracted 40 visitors.

February (sadly our last opening before lockdown) - celebrating Valentine's Day and Shrove Tuesday. Pancakes and waffles were served. Despite Storm Dennis over 30 people attended.

The accounts are very healthy and although we have been asking for £1 donation per adult most people have put in much more. We were able to purchase a hot water boiler that heled considerably and speeded up the tea and coffee making. The Café has achieved what we set out to do originally to 'keep in touch' with friends and neighbours. It has been particularly heartening to see neighbours who have moved away from the village returning each month to meet up with old friends as well as newcomers to the village coming along to get to know other villagers.

Suffolk Neighbourhood Watch Association

<u>Introduction</u>

The Suffolk Neighbourhood Watch Association (SNWA) Bury St Edmunds Area B covers the 6 parishes of Bradfield Combust with Stanning filed, **Bradfield St Clare**, Bradfield St George, Rushbrooke with Rougham, Little and Great Welnetham, and Nowton.

SNWA Area B is one of 5 areas in the Bury St Edmunds Police Reporting Area, covering approximately 180 sq. miles from Bradfield Combust with Stanningfield north to but excluding Thetford, and from Lackford east to Pakenham.

Police Recorded Crimes follow a National Crime Recording Standard (NCRS) and all 44 police forces (45 with London Transport Police) across England, Wales and Northern Ireland follow the NCRS, recording crimes in the **14 defined crime categories**: it is recognized that the reporting format has its limitations.

2019 Statistics

During 2019, **Bradfield St Clare** reported/recorded crimes extracted from the Suffolk Constabulary website where 2 incidents of violence and/or sexual. This of course is a very low crime rate and the lowest of our 6 Area B parishes. The 2019 monthly average for the whole of the 6 parishes Area B was 9 while the average for the whole of the Bury St Edmunds Police Reporting Area was 468 (of which between 80-90% of crimes occurred in Bury St Edmunds itself).

An unusually high number of ASB reports in one parish combined with a 55% increase in reports of violence and/or sexual incidents across Area B is the main contributor to the increase in the Area B 2019 monthly average of reported crimes – 9 in 2019 compared to 6 in 2018.

Area B Network

SNWA Bury St Edmunds Area B Network is extremely healthy and pro-active; at the time of writing, over 100 local residents receive alerts and monthly stats via e-mail (inc our County and Borough Cllrs as well as our MP's office); 1292 neighbours across 13 local villages (26 in Bradfield St Clare) are signed up to nextdoor.co.uk (highly recommended); alerts and monthly stats are posted on 3 parish/village facebook pages (Bradfield Combust and Stanningfield Residents, Rougham Village Community and Great Whelnetham Residents) reaching 662 followers; there is a dedicated NHW page in the monthly yellow St Edmunds Way magazine reaching all in 6 local villages, and the monthly stats are also uploaded onto the Bury St Edmunds Area B page of the SNWA's website. There is unquantifiable further sharing by parish councils (e.e newsletters, websites, posters, etc), groups and individuals as they see fit.
